Title: Service Contract of a certified/accredited consultant/registered company.

1. HISTORY OF SHELTER FOR LIFE

SFL is an international non-governmental organization, with its headquarters in Minnetonka, Minnesota, United States of America, and has been working in developing countries around the world since 1979. SFL works in more than fifteen countries around the world, guided by its philosophy of "restoring life by rebuilding communities". SFL provides emergency and development assistance in case of disaster or conflict, undertakes infrastructure reconstruction activities after such events, and provides micro finance products to support economic growth. SFL has helped millions of people by building or rehabilitating infrastructure as varied as temporary shelters, production roads, irrigation systems, schools, market infrastructure, etc. The NGO has also provided significant funding through thousands of micro-loans to help ease access to finance urgent needed funds to grow smallholders' production and business activities.

2. CONTEXT

Under the USDA/FAS Food For Progress (FFPr) program, Shelter For Life (SFL) is implementing a eightvear project called "Linking Infrastructure, Finance and Farms to Cashew" (LIFFT-Cashew) in Senegal, Gambia and Guinea-Bissau (SeGaBi) that aims at developing and upgrading value chain linkages necessary to support an integrated regional trade network for the cashew value chain. However, in order to make the value chain more attractive, more competitive and develop an inclusive economy in the SeGaBi, the along with other parts of the value chain, LIFFT-Cashew project is also focused on the development of the Organic Farming Certificate Program which remain barely explored in Africa and and SeGaBi region. The project is currently partnering with processors in Senegal, Gambia and Guinea-Bissau, linking them with cooperatives to purchase cashew nuts for processing and trading. Processors and cooperatives are very interested in implementing HACCP and NOP certification, but have constraints in terms of financial means and qualified personnel to invest in HACCP and NOP certification (USDA). It is in this context that the LIFFT-Cashew project intends to support cooperatives and processors in the SeGaBi region to obtain HACCP and NOP certification, in order to meet the requirements of local and international markets, including the EU and the USA, and to obtain good selling prices that will increase the income of value chain players. It is within this framework that the project has elaborated the ToR for the recruitment of an appropriate consultant to conduct training and ensure the implementation of the program.

3. OVERALL OBJECTIVE

Design and provide tailored training programs on HACCP, and NOP certification processes, covering key topics such as food safety including entire chain, traceability quality assurance, and regulatory compliance. This service aimed at to enabling producer members of the cooperative and the processor team to assimilate the CE848/18 and NOP specifications for organic farming and the new regulations in force, and to comply with the nut traceability system, in order to be certified on NOP and HACCP respectively both producers and processors. This support will also enable cooperatives and processors to familiarize themselves with the certification process, to ensure the sustainability of the organic program, and to develop and improve the value chain linkages needed to promote collective selling and processing of cashew nuts in order to support an integrated regional trade network for the cashew nut value chain

4. TASK AND RESPONSIBILITY OF THE CONSULTANT

Under the coordination of the Heads of the Agriculture and Market to Access component, the selected consultant/consulting company will provide service to support processors and cooperatives based on the following steps:

a. Implementation and final audit for CE848/18 and NOP certification

The consultant will be responsible for carrying out the following activities with the Cooperatives (producers cooperatives)



- Train producers on the new regulations on specifications for organic farming according to the EU Bio and NOP standard (848/18)
- Training on the internal control system and setting up the team
- Setting up an internal control system team
- Train the Internal Control System team on the procedure for the internal control of producers' plots and on the traceability procedure of the collection with the tools Nuts
- Development of procedure manuals and tools for the Internal Control System Manual as well as relevant forms for recording the process and transactions to meeting the standards.
- Organize the internal control committee of producers.
- Preparation for external audit
- Follow-up of organic and NOP certification files.

After the training sessions, the consultant will also ensure the implementation and enforcement of organic standards among producers, with the support of the Department of Agriculture and CMA team. The consultant will support the cooperatives in renewing their certification, to ensure the program's sustainability. The cooperatives involved (see below):

b. Implementation of recommendations and final audit for HACCP certification

The consultant will be responsible for carrying out the following activities with Smiling Coast company in The Gambia and ETHICAJOU in Senegal entire chain including:

- Development of procedure manuals and tools for the implementation of HACCP-compliant quality management systems at the plant, with a view to the company's HACCP certification.
- Accompany the Implementation of procedure manuals and tools for quality management systems.
- Training of production workshop managers and relevant staff in the tools and procedures manuals relevant to their position.
- Support the implementation and monitoring of the company's HACCP activities.
- Monitor and evaluate the implementation of the HACCP plan.
- Train quality team on HACCP quality procedures for each production workshop.
- Train HACCP team on good hygiene practices in production areas and food safety quality.
- Training company employees in good production hygiene practices.
- Correction of internal audit non-conformities;
- Preparation for external audits;
- Follow-up of HACCP certification files (completion of forms, audit planning).

- Demonstrated track record of successfully implementing certification programs for organizations similar to cooperatives, farms, processors.
